Dear Office of Charter Schools and School Redesign,

PVCICS intends to replicate the integrated regional Chinese immersion magnet school model established in Hadley in the greater Worcester area. The mission and key design elements remain the same, as the existing school in Hadley, and are attached. We plan to have the region of service support urban, suburban and rural communities and to achieve a socio-economically, ethnically, culturally diverse population similar to that which exists at out Hadley location. We plan to serve all students who apply, including at risk youth. The information in the attached *Information Sheet* is preliminary and subject to change.

The current board of trustees is applying as a proven provider. The current board includes parents, teachers and both a teacher and student representative. A former PVCICS teacher, who lives in the greater Worcester area is a member of the Board. PVCICS works with Mount Holyoke College, Smith College and the University of Massachusetts to develop K-12 teachers and social workers, who help in our Peace Room. PVCICS has relationships with K-12 schools in both mainland China and Taiwan to advance our cultural mission.

Shortly after receiving our charter in 2007, PVCICS received significant funding from the National Security Language Initiative to develop a K-12 pipeline of students with fluency in Mandarin. PVCICS has fulfilled the commitments made to the United States government in that grant application.

#### Mission and Key Design Elements:

PVCICS has three Key Design Elements: 1) High academic achievement, 2) Proficiency in Chinese language and 3) Develop understanding of Chinese culture. PVCICS's key design elements are embodied in its original charter application and subsequent amendment to be a K-12 regional public charter school dedicated to graduating students with high proficiency in both Chinese and English, combined with high levels of academic achievement. PVCICS is the first public charter school in the United States to offer a K-12 grade Chinese immersion program with the International Baccalaureate Diploma Program (IB DP). PVCICS is an "IB for All" school meaning all students in 11<sup>th</sup> and 12<sup>th</sup> grades take IB courses.

• The core of PVCICS's educational philosophy is that through early and sustained immersion in Chinese language with culture integrated throughout, students will achieve high academic attainment, be highly proficient in two languages and develop students' understanding of Chinese culture and the ability to interact successfully with others whose language and/or culture differs from their own. The percentage of the school day spent in a Chinese classroom and English classroom changes depending on the grade level, with a higher percentage of time in the Chinese classrooms in the early grades.

In grades K-5, Chinese language acquisition occurs naturally by using Chinese as the language of instruction during at least half of the school day. As is the practice in immersion programs, no English is used by the teacher during the Chinese portion of the day when core subjects, such as Math, Chinese Language Arts, and Science are taught. During the English portion of the day, English Language Arts and Social Studies are taught.

In grades 6 and higher, English is used as the language of instruction for core subjects however all students continue taking Chinese Language Arts in a two class period daily partial immersion program. In high school, all PVCICS students prepare to take rigorous International Baccalaureate (IB) Diploma Program (DP) courses in 11<sup>th</sup> and 12<sup>th</sup> grades and continue taking IB Chinese (Mandarin) courses.

PVCICS is faithful to the mission, vision and educational philosophy defined in its charter. PVCICS's student assessment data provides clear evidence of the students' ability to perform well academically in the Chinese immersion environment. Nationally, PVCICS has gained recognition as a Chinese immersion program and has since 2008 been invited to national conferences to speak about its program, curriculum and immersion model. In 2021, US News and World Reports ranked PVCICS as the #2 public high school in Massachusetts.
